Summary of Staff Review and Recommendations									
Grayson County will serve as the fiscal agent for this project and understands they are ultimately responsible for the use of and reporting on the funds. All three participating localities are contributing matching dollars from their direct distributions in the amount of \$10,000 each for a total match of \$30,000. The OAA request for funds is for \$260,199 for a total project cost of \$290,199. The Recovery Court program that serves this region began in 2018 and is an alternative to incarceration. The goal of the program is to break the cycle of addiction, crime, and incarceration. The program lasts an average of 18 months depending on each individual's progress through each phase of the program, with each phase consisting of specific requirements. Individuals participate in treatment based on needs, attend recovery court support groups weekly, community support groups twice a week, must comply with random drug testing, obtain employment unless legally disabled, and participate in recovery fitness. If awarded, the program will enhance services through addition of peer supports, additional hours for coordinator, hire support staff, purchase vehicle/insurance to assist with transportation (barrier in rural areas), rent space for recovery fitness, life coaching services, personal finance education, assist with housing, and offer in-patient treatment options. Evidenced-based support was provided and program will serve 50 additional individuals for FY24.									
Staff recommend full approval with the following contingencies before the OAA funds will be transmitted: 1) All cooperative partnership projects are expected to complete an operational agreement between all partners. 2) For any requests for procurements (RFPs) that are part of the project, the final cost of the procurement must be communicated to the OAA and if the resulting procurement would need an award adjustment, then approval by the OAA's Grants Committee is required. Additionally, the project should achieve sustainable funding without OAA assistance by FY29.
